# SoundExchange and Performance Royalties

- SX Collects and distributes performance royalties for digital performances
- Digital performances: Internet, digital cable, satellite television and radio
- Royalties paid to featured performers and sound recording copyright owners (record labels)
- Different from publishing/broadcasting royalties (BMI, ASCAP, SESAC)



# CPB-SoundExchange Agreement

- January 2009 agreement reached between CPB-SX
- CPB makes one-time payment to SX
- Covers **all** performance royalties for **web streams** from 1/1/2005 – 12/31/2010
- Covers NPR, NFCB, CPB Qualified, APM, PRI, PRX stations (~450)
- Does **not** cover downloads (podcasts)
- Royalty payments covered but stations must **still** report what music is being streamed



# CPB SoundExchange Reports

- Quarterly
  - Most stations: two 7-day consecutive periods (station's choice)
  - Some stations: full census reporting
- Music Aggregate Tuning Hours (MATH) per stream
  - Differs from standard SX reports (MATH vs. total ATH)
- For each song on each stream
  - Song Title
  - Featured Artist/Group/Orchestra
  - Album Title
  - Label
  - Actual Total Performances (play frequency x number of listeners)
- Includes songs on nationally syndicated programs



# CPB-Public Interactive Agreement

- May 2009 CPB picks PI to be the single SX reporting entity
- Stations give PI **raw** data; PI generates and submits reports to SX
- PI will
  - Collect raw data from stations (guides, playlists and streaming access logs)
  - Collect playlists for nationally syndicated shows from producers
  - Generate and submit quarterly reports to SX on behalf of stations
  - Develop tool to facilitate data collection from stations
  - Collect historic data between 2005 – 2008 from stations that have it
- CPB is covering the cost for stations for the first 2 years; after that, possible small charge from PI for administrative costs



# Data that PI will Collect from Stations

- Guides/schedule for each stream
- Playlist logs for locally produced shows
  - Song Title
  - Featured Artist/Group/Orchestra
  - Album Title
  - Label
  - Start time
  - End time OR duration
- Streaming access logs e.g. Shoutcast, Icecast logs
  - IP address
  - URL
  - Connection start time
  - Connection end time OR duration



# What Music Must Be Reported to SX?

- All performances UNLESS they are “brief AND incidental to other program content”
  - “Brief”:
    - Less than 30 seconds
    - Not an entire sound recording
  - Incidental
    - Musical transitions
    - Performances during news, talk, sports
    - Background performances
- Lots of grey area
- When in doubt, report it



# PI Data Collection Methods

- PI Composer & streaming clients – All set
- Non-PI Composer clients – Upload playlist logs to PI
- Non-PI streaming clients – Upload streaming logs to PI
- Upload Methods
  - Now: Upload to PI via FTP
  - Soon: Use new PI tool to update guide data/upload data files
- PI will collect playlists from national shows (e.g. C24, Jazz Gallery)



# Integration with Third Party Vendors

- PI will work directly with vendors when possible to obtain streaming log files
  - Limelight
  - StreamGuys
  - Live365
- Playlist application vendors that produce SX reports will need to provide raw playlist logs OR produce CPB-SX compliant reports
  - Spinitron
  - MusicMaster
  - Liquid Compass



# PI Tool Development

- New tool based on PI's Composer:
  - Composer Basic – Free for up to the first two years
    - Guide admin; upload playlist/log files; no public output
  - Composer Light – Guide admin & playlist admin; no public output
  - Composer Full – Guide & playlist admin; public facing output
  - Composer Basic & Light TBD



# Next Steps for Stations

- Register with CPB and accept SX Agreement

- Register with PI

- Identify playlist tools -> export data (tab-delimited file, spreadsheet, etc.)
- Identify streaming hosts -> request logs
- PI happy to work with hosts/vendors to obtain data directly
- Begin logging required data!
